**Nature of Event: Court's Decision– Dor Chemicals Ltd**

Following the Company's reports dated May 22, 2019 (reference number: 2019-01-043290) and May 23, 2019 (reference: 2019-01-043554), the Company hereby reports that Haifa's District Court has determined that the interim injunction delivered by the court on May 23, 2019 will stand as long as a different decision will be delivered by the court, and subject to complying with certain conditions by Dor Chemicals Ltd ("**Dor**").

To the Company's assessments, as long as said interim injunction will stand, it will enable unloading the MTBE ships and its transfer to Company's facilities throughout Dor's MTBE pipeline, which will enable the Company to continue producing a standard petrol.

According to the Court's decision, a separated pipeline of Dor will remain disabled, due to suspicion of leakage, until the completion of the inspection, its fixation by Dor and receiving permissions from all the relevant entities and authorities. Currently, the Company is unable to assess the duration that said disabled pipeline will be inactive. To the extent that the inactive period will continue more than several months, the Company cannot invalidate the possibility that this event may have a material adverse effect on Company's results.

The Company's assessments mentioned above concerning the possibility of unloading and transferring of MTBE to its facilities and concerning the possible effect of disabling the separate pipeline on company's results constitutes a "forward-looking information". These assessments are based mainly on the interim injunction delivered by the Court, and on Dor's operational

capabilities and on assumptions concerning the prices of the relevant products. There is no certainty regarding the realization of the abovementioned assessments and to the extent that they will not be realized, it may cause a material effect on Company's capability to provide standard petrol and/or on Company's results of activities.
